Chairman Ellis called the meeting to order, extended a welcome, and read the thought for the day. The invocation was given by Pastor Ronny Brannen, Prospect United Methodist Church, and the Pledge of Allegiance was led by View Point Health CEO David Crews and COO Jennifer Hibbard followed by a power point presentation on the View Point Health Program. Chairman Ellis recognized Pastor Ronny Brannen who received the 2014 Martin Luther King I Have a Dream Award. The board and audience expressed their congratulations with a round of applause and a group photo was taken with Pastor Brannen and the BOC.

401A PLAN ADMINISTRATION (FROM JANUARY 7, 2014 MEETING) County Manager John Middleton addressed the board regarding the 401A Plan.

- GEBCorp and ICMA-RC previously made presentations to the board in December.
- Provided the board the 401 Fee analysis earlier in the week (BOC requested analysis at the January 21st meeting)
- Provides a side by side comparison of each company's plan showing their calculated annual plan and administrative fees.
- He briefly went over the analysis and answered the board's questions.

The board entered back into regular session with a motion by Commissioner Douglas, second by Commissioner Maddox.

Motion carried unanimously

ADMINISTRATION: SUCCESSION PLANNING

- Have county attorney create a job description for an assistant county manager based on current county manager job description.
- Commissioner Maddox who duly made the motion noted that he had been researching and praying about this decision for several months.
- Commissioners stated they wanted someone on board immediately to begin learning from Mr. Middleton...noting especially the FY2015 budget process.
- One by one they expressed their deepest confidence, respect, and appreciation for Mr. Middleton and the outstanding job he has done for Newton County, i.e. Superb, capable, outstanding county manager Incredible job

Can't be replaced...will just find someone to follow in your footsteps. Worked with him since he came on board and appreciate that he doesn't tell you what you want to hear, but what you need to know.

Greatest respect for him.

Thankful for the privilege of working with him.

Thanks for staying with us for anther year and for helping guide the new person through a smooth transition.

Thank you for everything you have done for us.

- Commissioner Schulz registered her concerns that there has not been adequate time given to this decision, was not a formal interview process followed and was disappointed that other prospective candidates were not given an opportunity to be interviewed.
- She stated that she felt like timing was off, while the other board members felt timing was of the essence, because of the need for the person to be with Mr.

Middleton as much as possible from now until Mr. Middleton's retirement in September.

- Commissioner Schulz told the board she would still like for ACCG Government Relations representative Dave Wills to come and meet with the board at a couple of work sessions to look at the county's organizational chart and the county charter.
- Commissioner Douglas commented that the board needed to do this now to have someone in place to overlap with Mr. Middleton, especially the budget cycle.
- Commissioner Schulz stated the following into the record:

 "I have the utmost respect for Tom Garret, but the process by which we have proceeded with this appointment is very concerning to me. We had no formal interview process; we had no documentation in front of us to make this decision. At this time I am not prepared to vote on this decision. We had nothing in our packets that gave us information, except a line item that said succession plan. I would have preferred to wait until our next board meeting to make a decision so that we could have a formal process to interview potential candidates, but we were not afforded that opportunity.

Motion by Commissioner Maddox, second by Commissioner Douglas, to offer the position of Assistant County Manager to Tom Garrett beginning January 27, 2014 or as negotiated. Also, request county attorney's office to create a job description based on current county manager job description, and to include compensation package for board approval.

Motion carried 4 to 1 with Commissioner Schulz voting in opposition to the motion.

With no further business, a motion by Commissioner Douglas, seconded by Commissioner Sims, the meeting adjourned at 10.30 p.m.
