Residential User Access Permits are available for purchase at these locations beginning **September**, **2016**. User Access Permits can be purchased for \$50 each. Lost or damaged permits can be replaced for \$25, limit one replacement tag per year/per household and full price thereafter. All locations accept all major credit cards and Checks. There is a 3% surcharge added to all credit/debit transactions. **Please make checks payable to Newton County**. A \$35 fee will be assessed on all returned checks. You may also **mail in your application** along with check payment and proof of residency to: 4136 U.S. 278 #A Covington, GA 30014. Absolutely no refunds will be issued. We do not accept credit/debit payment through the mail.
