

And the better to secure the payment of this bond, in the event of forfeiture, we, each for ourselves and families, and as the head of respectable families, renounce and waive all right and benefit of the homestead exemption laws of this State, whether the same be guaranteed by constitutional or legislative provision providing for homestead and exemptions to the people of Georgia, and each of us assert and say that we have never taken or availed ourselves of any homestead or exemption under the laws of this State, or of the United States, or elsewhere.)
